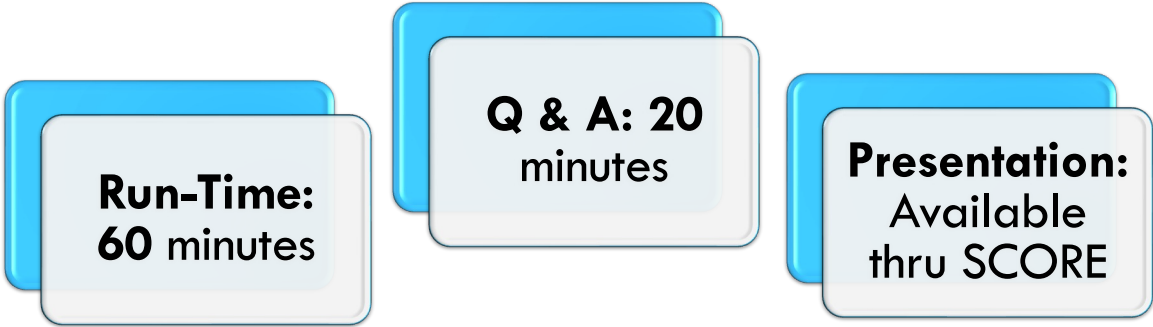

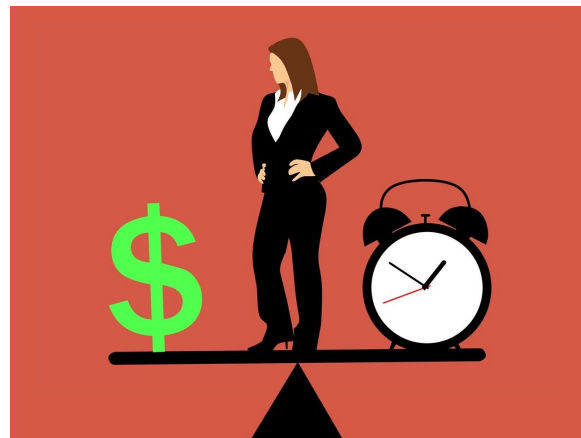

RESOURCES: Education-based Partners



1. **High Schools** – Guidance counselors or clubs to offer service hour opportunities.
2. **GED and Adult Education Programs** – Invite students for resume-building service.
3. **Homeschool Co-ops** – Share flyers and offer family-friendly group volunteer events.
4. **Afterschool Providers (Boys & Girls Clubs, YMCA)** – Joint projects w/parents and teens.
5. **Colleges & Universities** – Career services to offer volunteer or internships opportunities.
6. **Fraternities/Sororities** – Propose group service projects tied to philanthropy requirements.
7. **Parent-Teacher Associations (PTAs)** – Share your flyer with parents interested in community service.
8. **Alumni Associations** – Invite members for professional or skilled volunteering.

RESOURCES: Businesses & Employers



1. **Corporate HR or CSR Departments** – Propose employee volunteer days or service events.
2. **Banks & Credit Unions** – Often allow employees to volunteer; ask to speak at staff meetings.
3. **Law Firms & Accounting Firms** – Offer skills-based volunteering (board service, pro bono work).
4. **Professional Associations (CPA, Bar, HR, Marketing)** – Propose skills-based volunteering (e.g., board service, marketing help).
5. **Real Estate Agencies** – Invite them to sponsor and volunteer at community events.
6. **Grocery Stores** – Ask to post flyers in breakrooms or partner for holiday service drives.
7. **Restaurants & Coffee Shops** – Post flyers on bulletin boards or recruit staff for short-term events.
8. **Fitness Centers & Yoga Studios** – Team volunteering or co-host community wellness events.
9. **Chambers of Commerce** – Ask to present at a meeting or be included in the member newsletter.
10. **Coworking Spaces (e.g., WeWork, Regus, local hubs)** – Post flyers or host a volunteer mixer.

Civic and Government Agencies

1. **Libraries** – Promote on library boards.
2. **City Councils or Mayors' Offices** – Be listed as a partner or included in city e-newsletters.
3. **Courts** – Register to accept court-mandated volunteers.

1. **Hospitals** – Partner on health fairs.
2. **Community Health Centers** – Recruit volunteers for health education or outreach.
3. **Mental Health & Recovery Centers** – Invite peer support volunteers or wellness event support.

WHAT COULD GO WRONG

Your Organization:

- Miscommunication of Roles and Expectations
- Lack of Supervision and Training
- Lack of Data Security
- No Background Check
- No Liability Insurance for “Volunteer-Related Incidents”
- Legal Compliance Failure (Charitable Immunity, wage and hour laws)

Your Volunteers:

- Misrepresentation
- Breach in Data & Sensitive Information
- Non-compliance with policies
- Criminal behaviors pose risk
- Injuries caused by volunteers
- Acts not covered by Volunteer Protection Act.
- Burn out

INJURIES

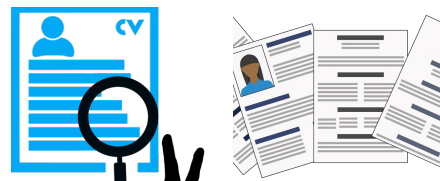
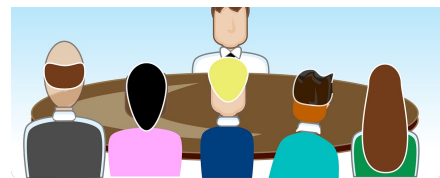
LAWS

- Volunteer Protection Act** - federal level of protection to volunteers, directors, and officers of nonprofit organizations from liability for harm caused by their acts or omissions on behalf of the organization, given the act was within the scope of their responsibilities and they were properly licensed or certified.
- Charitable Immunity** - some states in the U.S. protect nonprofit organizations from liability in lawsuits against alleged negligence.
- Wage and hour laws** -Fair Labor Standards Act (FLSA), regulate the status of volunteers versus employees, and stipulate when an individual must be compensated as an employee rather than serve as a volunteer.

INTERVIEWING QUESTIONS

Get to know your new volunteers and their motivation for getting involved. Here are some questions you can ask:

- How did you hear about us?
- What motivated you to get involved?
- What type of projects are you interested in?
- Do you have any special or technical skills?
- How do you prefer to be contacted?
- What resources do you need from us?
- Is there anything that we have not asked, that you would like for us to know?

TRAINING VOLUNTEERS

Onboarding - a deliberate process of helping new volunteers acquire the necessary knowledge, skills, and behaviors they'll need to become effective members of your organization.

As a rule of thumb, make sure that every new volunteer receives at least:

- A warm welcome
- Some background information about your nonprofit
- A task description & explanation of how their time helps your cause
- An introduction to a staff member that they can go to for help
- A handout that sums it all up in case they forget!

Dear Kelly,

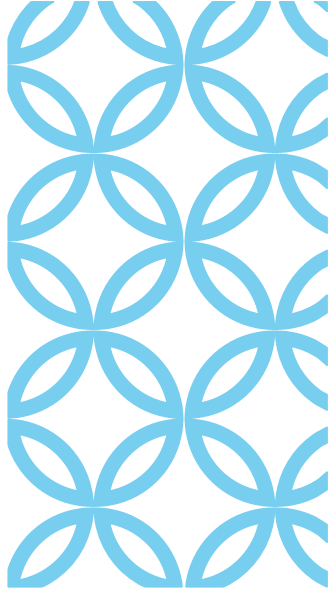

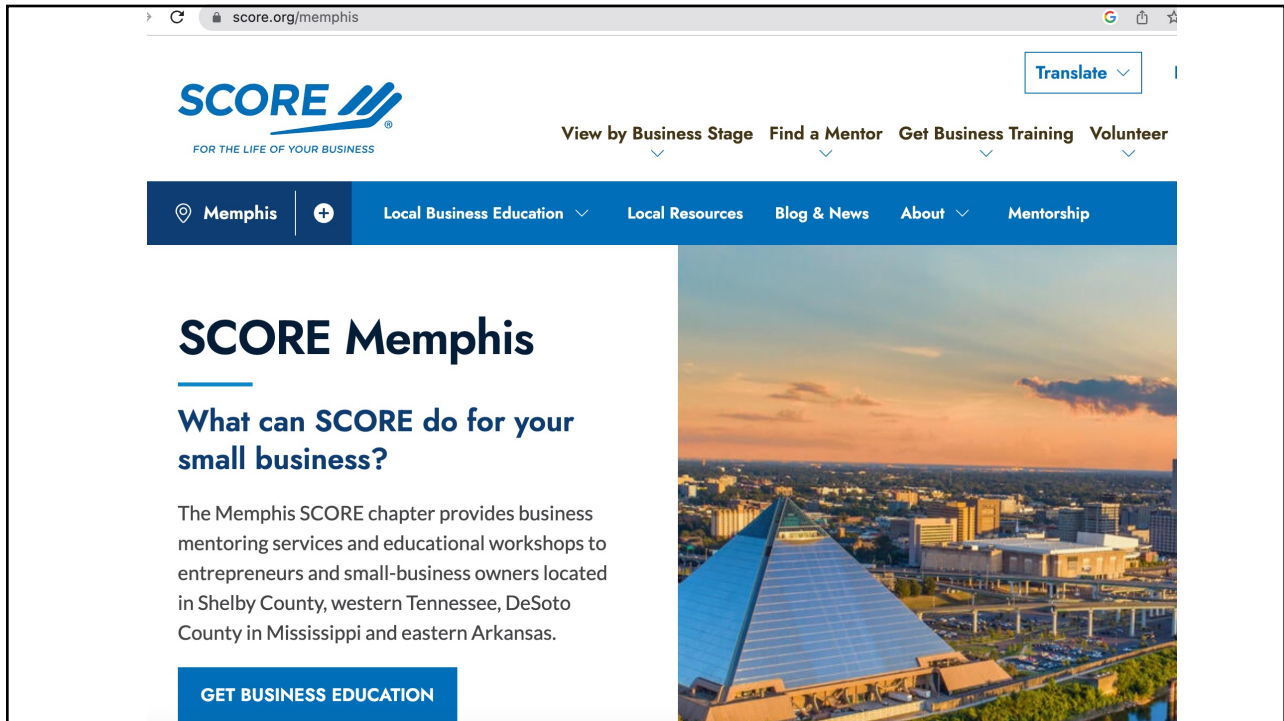
